**Protandim** to Party #2's per delivery instructions above. Party #1 is responsible for the packaging and the safe delivery of the product to Party #2 (and may choose to purchase package insurance). The US Postal service "Flat Rate Priority" is recommended for shipping. A flat rate medium box (approx cost \$12.00) can be used to ship up to 49 Protandim.
